5. Declaration

We hereby declare that the above information is correct and complete. Should there be any changes, we will inform you immediately.

The grant will be used by us economically, sparingly, and exclusively for the above-mentioned project. If the funds are not used for the intended purpose or if the receipts are incorrect or incomplete the Centre for Global Ministries and Ecumenical Relations (ZMÖ) is entitled to reclaim all funds. In the event of any contract violation, the ZMÖ is to be immediately reimbursed for any distributed funds – at ZMÖ discretion, in full or partially. We acknowledge that passing on any funds to third parties without prior written ZMÖ consent is not permitted.

We are aware that we must make an appropriate contribution of our own (Monetary or non-monetary such as labor input, providing of building or land). We commit to procure and draw from, all to us available, third-party funds prior to using ZMÖ funds.

We declare that we have not yet started implementing the project. We agree that the project must be started within 12 months from the date of approval and that the project duration must not exceed 36 months. Within six months of project completion, we will document the implementation and results of the project in an appropriate form and submit a full report to the relevant ZMÖ regional desk. The final report (narrative and financial report) shall include a cost and financing overview as well as receipt overview. Further, we agree to provide copies of receipts on demand.

We acknowledge that a grant may be subject to further conditions and/or requirements and that we may have to provide evidence that the conditions and/or requirements have been fulfilled by us. We are aware that any payment approval becomes invalid if these conditions and/or requirements are not met.

We acknowledge that the ZMÖ is entitled to make enquiries concerning the project with authorities, departments, organisations, banks, private persons, etc. and, if necessary, to consult with other sponsors. We further acknowledge that the ZMÖ is entitled to request bank statements, financial statements, audit reports, management reports, litigation documents, receipts and other business documents at our expense and to check the use of the funds by means of local surveys. We will keep the documents required for this purpose in accordance with the legal regulations, keep them available for inspection and provide the necessary information.

We agree that our documents may be stored for a longer period of time within the framework of the Data Protection Act for processing and administrative purposes and may be passed on to third parties for the purpose of processing.

We agree that the funded project may be presented publicly (by radio, television, press, newsletter, website) without prior consent and or separate payment. We agree that these representation rights may be transferred to third parties.

In the case of public presentation, we will indicate in an ZMÖ approved appropriate manner that our project was supported by funds from the Centre for Global Ministries and Ecumenical Relations of the Evangelical Lutheran Church in Northern Germany.
